## 2016 Financial Report

Della Clement presented the financials that included: All 102 lots paid the dues for 2017 4 lots have outstanding fines not paid at a total of 375.00 80 letters were sent out as correction notices. 52 of the letters were corrected. 27 late fees were reversed and the owners were not charged.

### Storm Sewer Maintenance Update

The filter vaults were inspected in June of 2017 and are in compliance. The HOA was not charged for the inspection visit. The filter will be inspected in 2018 and replaced in 2019.

## **Reserve Study**

The Reserve Study has been completed and is posted on the RRC Website.

## 2018 Proposed Budget Review & Vote

*Dues were decreased from \$355 in 2017 to \$325.00 in 2018.* Breakdown of annual dues 45% or \$160.00 goes into maintenance and utilities 38% or \$127.64 goes to administrative and property management fees for the HOA 12% or \$45.00 goes to 3 year Storm Drain reserve (this will be earmarked and not accessible) 5% or \$16.00 goes to insurance. Payments will be split again this year with first installment dues January 2018 and second installment due in March 2018. Note: The 2018 budget was not approved by the homeowners in attendance but by lack of guorum, the budget was then approved by the board of directors.

#### Election of 2 vacant board positions for 2018

Homeowner's were asked if there were any volunteers to serve. There were no volunteers. The positions will remain open. The board thanked Tom Stoddard for his service as Treasurer in 2017.

#### Garbage Can CC&R revision Impasse

Impact Property Management will conduct canvasing for all lots that have not voted in 1<sup>st</sup> quarter of 2018.

# Parking Issues on 71<sup>st</sup> and 85<sup>th</sup> ave
